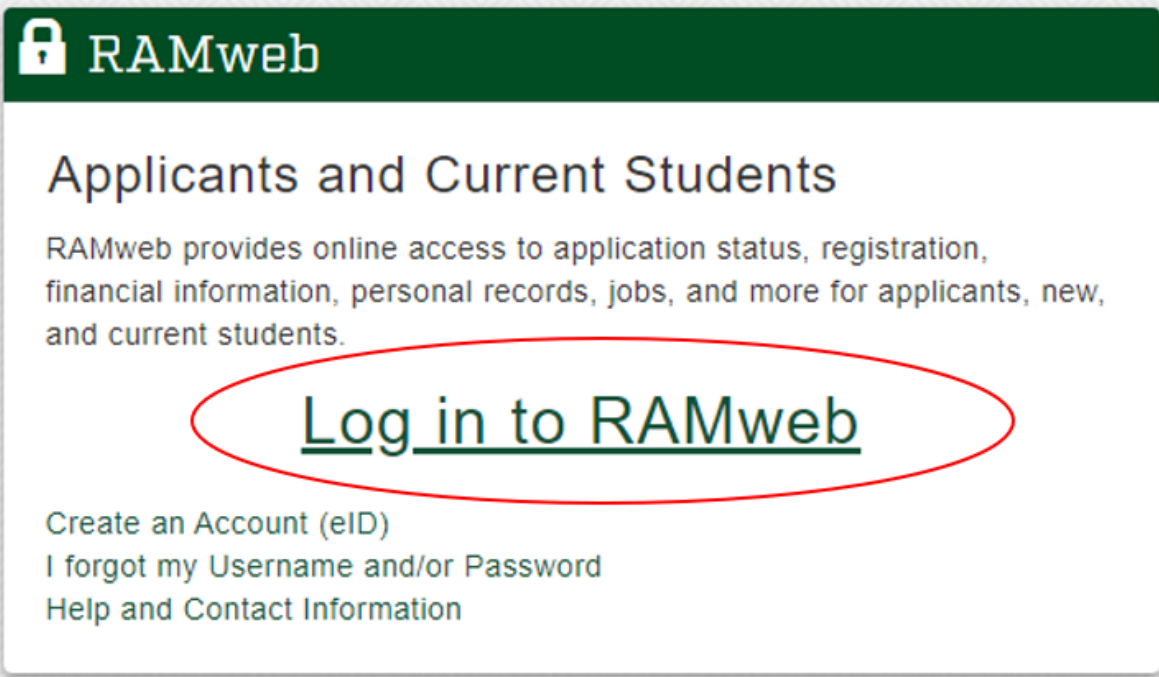


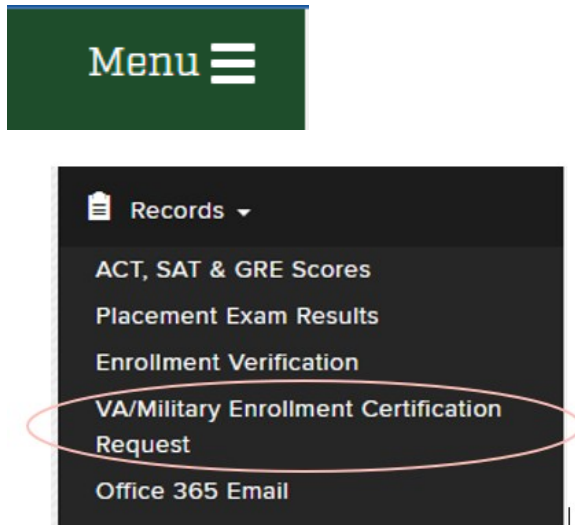
How to Authorize Use of Military/VA Education Benefits

RAMweb is the student portal. If you are a parent or family support, please ask your student about setting up a [FAMweb](#) option for you.



Second, navigate to the form:
