### **Degree Conferral & NG/Incomplete Grades**

Degrees cannot be awarded to students who have an Incomplete or NG grade on their record.

As a reminder, students who take <u>incomplete grades</u> should not register for the same course in a later semester. They should instead work to finish the course with the instructor who provided the incomplete. If the course is registered for a second time, the previous instance will turn to an F grade after a year and may prevent the conferral of the student's degree.

Please work with your students who have incomplete or NG grades (not including Planned Leave or Study Abroad) and remind them that they must have a traditional or S/U grade awarded prior to degree conferral.

# Do you have an advisee who will be attending the Fall 2023 or Spring 2024 Semester at Sea voyage?

Students attending the <u>Fall 2023 voyage</u> will be able to register for their Spring 2024 classes while on board.

Students who will be attending the <u>Spring 2024</u> voyage will begin registering this fall. If you have an advisee who will be participating, it may be worth discussing both Spring 2024 voyage classes and their Summer/Fall 2024 schedules when you meet with them since registration will open while they are on the ship.

## **Employee Study Privilege**

Fall Semester 2023 will be here before you know it... so if you're thinking about taking advantage of the Employee Study Privilege (ESP) Program, be sure to submit your ESP form for on-campus courses to the Office of the Registrar (for CSU Online courses, submit a separate form to CSU Online) by end of day Monday, August 21, 2023. Before submitting your form, carefully review it to make sure it is complete, (i.e., all required signatures are present, and the applicable boxes and blank fields in every section on pages 1 and 2 have been completed) so as not to delay processing. To easily upload your ESP application, simply go to our website. Please note, Employee Study Privilege Program benefit year commences Summer session and ends Spring semester.

Billing credit for the study privilege will be applied to your account within 3-4 weeks after the Fall 2023 census date (September 6, 2023). Because the Study Privilege may not be credited to your account until AFTER the September 11th payment due date, the payment deferral charge will be waived in September. Any remaining balance after the credit is applied to your account will be due October 10, 2023. You can access the current ESP form on the HR website or the RO ESP Page which also houses FAQ's about the program. Please also note, employees registering at an undergraduate level, who are classified as Colorado residents for tuition purposes, must apply for and authorize the use of COF. Failure to authorize COF will result in an additional charge to your student account. Undergraduate students with special approval to register for 600-level courses are not eligible for COF.
